

INFORMATION ON SHARE BUY-BACK PROGRAMME

Milan, 1st December 2014. We hereby notify that, in the framework of the authorization to buy and disposal of treasury shares under the Company's Shareholders' Meeting resolution adopted on 16th April 2014 and following the launch of a buy-back programme by the Board of Directors on 6th November 2014, Prysmian S.p.A. (the "Company") purchased on the regulated market managed by Borsa Italiana from 24th to 28th November 2014, both included, no. 237,170 shares with an average price of Euro 14.6153 per share, for a total amount of Euro 3,466,322.

Here below the details of the buy-back transactions on daily basis:

Since the beginning of the buy-back programme, the company has purchased no. 1,054,240 ordinary shares for a total amount of Euro 15,069,805.

On November 28th, 2014, considering also the abovementioned transactions, the Company directly and indirectly owns no. 2,508,699 treasury shares, equal to about the 1.2% of the share capital, as currently attested at the Milan Company Register.
