**INFORMATION ON SHARE BUY-BACK PROGRAMME**

*Milan, 12 June 2017.* Prysmian S.p.A. hereby notify that, in the framework of the current authorization to buy and disposal of treasury shares under the Shareholders' Meeting resolution adopted on 12<sup>th</sup> April 2017 and of the share buy-back programme launched by the Board of Directors on 12<sup>th</sup> January 2017, has purchased on the regulated market (MTA) managed by Borsa Italiana from 5<sup>th</sup> to 9<sup>th</sup> June 2017, both included, no. 34,744 shares with an average price of Euro 25.2352 per share, for a total amount of Euro 876,772.05.

On the basis of information provided by the intermediary agent appointed for the implementation of the share buy-back programme, here below the details of the shares purchase transactions, on daily basis, in aggregate form:

Since the beginning of the share buy-back programme, Prysmian S.p.A. has purchased no. 3,600,070 ordinary shares for a total consideration of Euro 88,535,420.76.

As of June 9<sup>th</sup>, 2017, considering the abovementioned purchases, Prysmian S.p.A. directly and indirectly owns no. 6,194,000 treasury shares, equal to about the 2.86% of the share capital.
