Milan, 24 November 2014. We hereby notify the new composition of the paid-up share capital of Prysmian S.p.A. (the "Company"), following the issue of shares under the Company's Shareholders' Meeting resolution adopted on April 14th, 2011, serving an incentive plan for Prysmian S.p.A. and its subsidiaries' employees, approved by the abovementioned Shareholders' Meeting.

The Company issued, from 27th of October to 21st of November, a total amount of 484,559 ordinary shares, fully paid-up.
